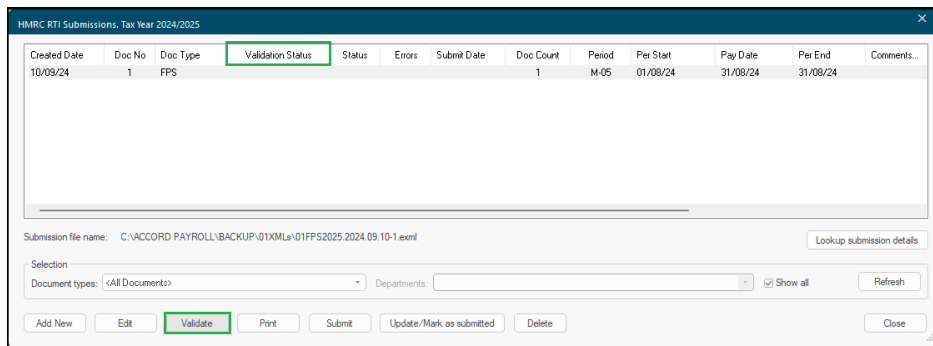

New functionality

Validation of RTI submission files

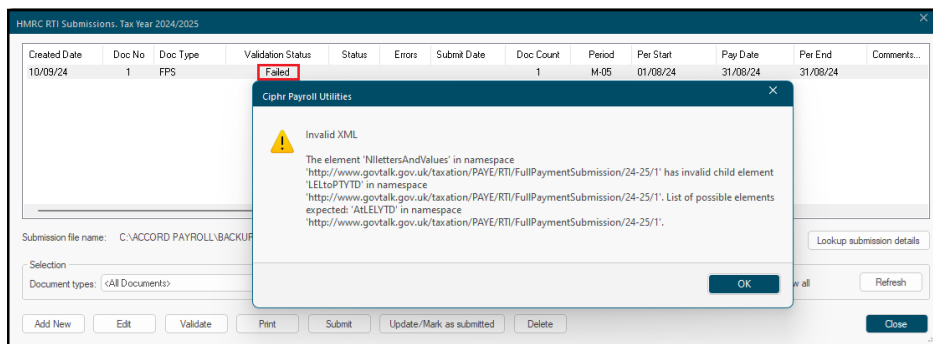
From the 2024/2025 tax year onwards, Ciphr Payroll users will be able to validate RTI submission files against HMRC schema rules before submission to HMRC, ensuring higher quality results for the files submitted.

On the RTI Submissions dialog, users will see a new 'Validate' button positioned between the 'Edit' and 'Print' buttons.



To validate a file, select a row from the list and press the 'Validate' button. The selected RTI submission will be checked against the HMRC schema rules.

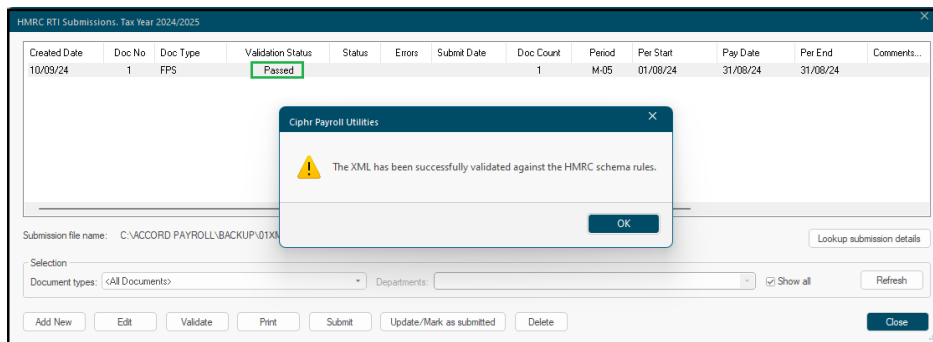
If the file contains errors, an error message will be displayed in a pop-up box.

Successful validation will also be confirmed in a pop-up box.

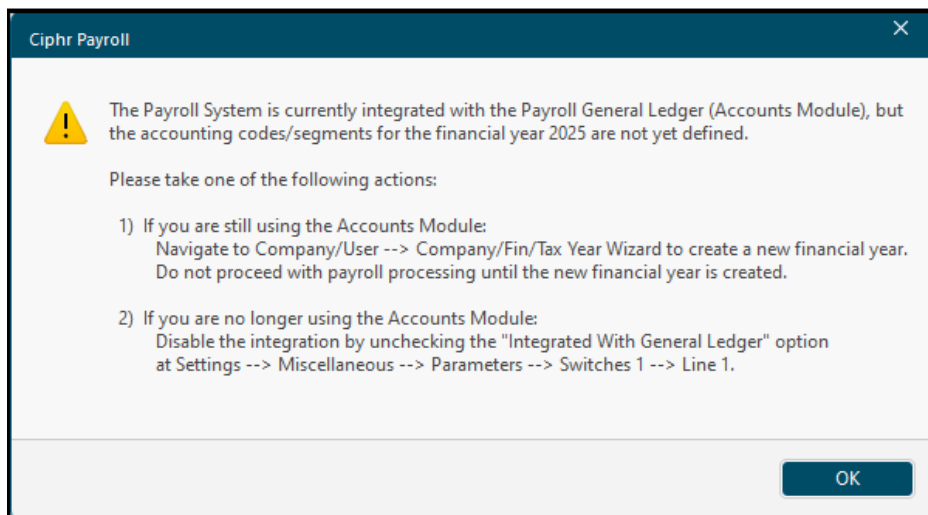


Validation of the RTI files can be repeated multiple times if needed, and is optional, therefore does not prevent users from submitting the files.

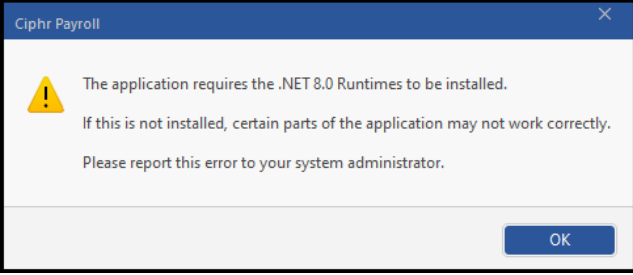
